# **Rental Contract**

## Terms and Conditions

#### **Deposit**

A booking and administration deposit of 50 percent of the rental fee is required from the renter at the time the renter books the trailer for a rental period. This deposit is required before a booking is confirmed. Payment can be made by cash, cheque (made payable to Scotland Cooler Solutions) or e-transfer (made to accounting@scotlandcoolers.ca).

If for any reason the trailer is not available for the time reserved, Scotland Cooler Solutions is liable to the extent of the deposit only.

### **Refund Policy**

If the renter cancels the booking at any time in advance of the commencement of the lease, all or any portion of the rental period, the following refund policy shall apply:

- If notice of cancellation is received more than 30 days in advance of the rental date, the full booking and administration deposit with be refunded;
- If notice of cancellation is received more than seven days but less than 30 days in advance of the rental date, 50% of the booking and administration deposit will be refunded:
- If notice of cancellation is received seven days or less in advance of the rental date, there will be no refund of the booking and administration deposit;
- No refund is given for early returns

#### **Prohibited Use**

The trailer of this contract will not be used:

- a. By anyone not specifically named in this agreement;
- By anyone whose ability to operate the tow vehicle is impaired by alcohol, drugs or fatigue;
- c. Outside of Ontario without written consent:

d. In violation of any law.

### **Damage**

Any damage repairs will be invoiced separately to the renter.

The renter is entirely responsible for all loss, damage and/or mechanical repairs to the trailer and any accessories, regardless of fault, resulting from abuse, misuse or negligence.

The renter agrees to pay a sum equal to the regular daily rental rate of the trailer for each day the trailer is unavailable for rent while any damage and/or mechanical repairs are made.

The renter will not remove, alter, disfigure or cover up any numbering, lettering or insignia displayed upon any equipment and will ensure that no equipment is subjected to careless or needlessly rough usage.

Scotland Cooler Solutions is not liable for the death, disability, personal injury, property damage, property theft or actions of any kind which may hereafter accrue to me or my associates.

Scotland Cooler Solutions is not responsible for any and all liabilities and claims made by other individuals or entities as a result of any of my actions or the actions of my associates.

## Reporting of Accidents and Theft and

The renter will report any accident or theft involving the trailer to the police and shall complete a written report as soon as possible and in any event within 24 hours.

Should the equipment become unsafe, malfunction or require repair, the renter shall immediately cease using the equipment and notify Scotland Cooler Solutions if such condition is the result of normal operation. Scotland Cooler Solutions will repair or replace the equipment with similar equipment in working order, if such replacement equipment is available. Scotland Cooler Solutions has no obligation to repair or replace equipment rendered inoperable or which becomes unsafe, malfunctions or requires repair due to misuse, abuse or neglect of any kind by, or on behalf of, the renter.

#### **Personal Property**

Scotland Cooler Solutions is not responsible for loss or damage of any property left in, upon or carried in the trailer. The renter is responsible to provide a lock for the trailer, should the renter wish to use one.

#### Loads

The renter agrees to pay for any and all damage and/or mechanical repairs resulting from the trailer being overloaded, improperly loaded, resulting from an insecure load or used outside of its intended purpose.

#### **Licenses and Permits**

Any additional licenses or permits required by provincial authorities are the responsibility of the renter.

### **Return of Trailer**

The renter will make the trailer and equipment accessible and available at the time of pick up or rental charges will continue until said trailer and equipment is accessible and available. A separate pick up charge will apply for each trip required.

All equipment must be returned with the trailer.

Please return the trailer in a tidy condition to avoid extra charges. A cleaning fee will apply for any trailer not returned in this condition.

Any amounts due and unpaid shall bear interest at the rate of 2% per month or 24% per year.
